

Re: Discussion, Consideration, and Possible Action on Change Order #1 for University Boulevard Improvements to Install a Parallel Sewer Main to Add Necessary Sewer Capacity.
 1) Declare an emergency under 61 O.S. § 130. F., Public Competitive Bidding Act of 1974 due "to conditions resulting from a sudden unexpected happening or unforeseen occurrence".
 2) Consider Action on Change Order #1 with Schiralli Construction Corp for the amount of \$581,397.98.

While working on the drainage improvements on the University Blvd improvements, several unexpected and unforeseen issues with the current sewer line were encountered.

- The line is located in places where it blocks designed drainage.
- The line is under sized to carry sewer for future development.

Wall engineering has proposed to run a parallel line on the north side of University Blvd to connect customers on the north side of University, relieving pressure on the line on the south side of the street and ultimately increasing the sewer capacity of the entire area.

- The change order from Schiralli is for the amount of \$581,397.98.
- The change order also extends the completion date of the project by 96 days.
- Substantial Completion: August 6, 2022
- Ready for Final Payment: September 5, 2022
