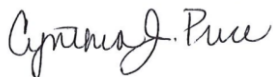

This contract, made and entered into by and between **Native Energy Source, LLC.**, as Party of the First Part, hereinafter designated as Contractor, and **City of Durant, Oklahoma** as Party of the Second Part, hereinafter designated as the Owner, to-wit:

WHEREAS the Contractor is the lowest and best bidder for the total bid price, as accepted, of Two Hundred and Sixty-Six Thousand and Three Hundred Eighty Four Dollars, (\$ 266,384);

NOW, THEREFORE, the Contractor, for the consideration herein named, hereby agrees to do, and complete the work above mentioned in accordance with the plans adopted and approved by the Owner and on file in the office of the Durant City Clerk, which plans and specifications are made a part of this contract by reference as if attached hereto or written in details herein.

It is further agreed that payment for the aforesaid work or material will be made under the terms of the Contractor's bid, as accepted, as provided in the specifications and that, upon final completion of this contract work, the Contractor will receive the full compensation payment according to the schedule of prices as contained in his bid, as accepted, and that, upon receipt by the Contractor of final claim, the same shall be paid in full for all claims of every kind and description the Contractor may have arising out of this contract.
